Dear Executive Director Bridwell:

East Kentucky Network, LLC d/b/a Appalachian Wireless ("Appalachian Wireless") hereby submits this letter in response to the Commission's *Order* entered on February 21, 2022, which requires ETCs participating in the Affordable Connectivity Program ("ACP") to detail the service plans offered to Kentucky Lifeline customers, the total cost of the program offered through the ACP, and how the ACP and federal and state Lifeline will be applied to eligible Lifeline plans.

At the present time, Appalachian Wireless allows eligible customers in qualifying households to apply the Affordable Connectivity Program discount only to one of these plans:

- Unlimited¹ 25GB High Speed Data Plan Standard: Smartphone - Monthly recurring cost of \$95.00² (one line). Includes unlimited voice. Tablet - Monthly recurring cost of \$65.00² (one line).
- (2) Unlimited¹ 25GB High Speed Data Plan Advantage: Smartphone - Monthly recurring cost of \$75.00² (one line). Includes unlimited voice. Tablet - Monthly recurring cost of \$65.00² (one line).

For customers who qualify for both Lifeline and ACP and choose to apply both program discounts to their Appalachian Wireless service, discounts are applied as follows:

The Kentucky Lifeline discount can be applied to any Nationwide Mix and Match Plan, the Nationwide Unlimited Plan, or the Nationwide Unlimited+ Plan. Beginning April 15, 2022, eligible customers in qualifying households may apply the ACP discount to any plan that includes broadband data. **Attachment 1** lists the plans to which the Kentucky Lifeline discount may be applied, and shows how the discount will be applied with the ACP discount beginning April 15, 2022.
