**MOTION TO WITHDRAW**

OnStar, LLC, d/b/a Telematics Services (“OnStar”) moves to withdraw from the above-referenced case. In support of its motion, OnStar states:

1. On February 1, 2016, the Kentucky Public Service Commission (“Commission”) issued an order initiating a case on its own motion to investigate “the current and future funding, distribution, and administration of the Kentucky Universal Service Fund (“KUSF”).”<sup>1</sup>

2. Although the Commission made each local exchange carrier, commercial mobile radio service (“CMRS”) provider, and eligible telecommunications carrier (“ETC”) a party to the proceeding, it also afforded parties that are not Eligible Telecommunications Carriers (“ETC”) in Kentucky receiving both (a) federal universal service fund (“USF”), and (b) KUSF support the opportunity to request permission to withdraw.<sup>2</sup>

3. OnStar resells CMRS and registered as a utility on November 7, 2007.

4. OnStar is not an ETC and has never received support from the KUSF. Therefore, OnStar is eligible to withdraw from the case.

5. Withdrawal is appropriate for OnStar because the funding and administration of the KUSF does not materially impact its Kentucky operations as long as the funding mechanism remains uniform among providers of telecommunications services and telematics.
