**MOTION TO WITHDRAW AND FOR EXTENSION OF TIME**

Dialog Telecommunications, Inc. (“Dialog”) moves to withdraw from the above-referenced case. In support of its motion, Dialog states:

1. Dialog is a competitive local exchange carrier providing wireline telecommunications services and is a nominal party identified by the Commission’s February 1, 2016 Order establishing this inquiry into Kentucky’s Universal Service Fund (“KUSF”).

2. Dialog was granted ETC status within certain BellSouth wire centers in Case No. 2005-00479, but has never requested reimbursements from the Kentucky Universal Service Fund.

3. At page six of the Order, the Commission stated it would provide any carrier that is not an ETC in Kentucky receiving both federal USF and state support an opportunity to withdraw from the case. As noted above, Dialog does not receive both federal USF and state support.

4. Dialog collects the state-prescribed KUSF charge and remits it pursuant to the instructions of the Telecommunications Branch, Division of Financial Analysis.


5. Dialog will monitor any compliance items affected by the proceeding but hereby requests to be dismissed as a party.

6. Pursuant to 807 KAR 5:001, Section 10, Dialog requests an extension of time for filing this motion. In the event the Commission is not inclined to dismiss Dialog as a party,

Dialog requests a ten day extension of time to respond to the Commission staff data requests otherwise due on April 27, 2016.

For the above stated reasons, Dialog respectfully requests that the Commission grant it permission to withdraw from further participation in this proceeding.


