Response to Commission Order

In response to Commission Order Dated February 21, 2022, Logan Telephone Cooperative, Inc. dba LTC Connect (“LTC”) responds as follows:

1. The list attached hereto as Attachment “A” identifies all the Affordable Connectivity Program (“ACP”) services provided by LTC under the Federal ACP program at the date of this submission.
2. For those LTC ACP services that are not unbundled from its phone services, LTC applies federal support before applying Kentucky Lifeline support.
3. Unlike the Emergency Broadband Benefit program, Affordable Connectivity Program providers may modify their available plans at any time. Should LTC choose to do so, it will prioritize the application of the state and federal lifeline credits consistent with the Commission’s February 21st Order.
4. LTC believes it is fully compliant with state and federal ACP requirements.
