Response to Commission Order

In response to Commission Order Dated February 21, 2022, North Central Rural Telephone Cooperative, Inc. and its wholly owned subsidiary North Central Communications (collectively, “NCC”) responds as follows:

1. The list attached hereto as Attachment “A” identifies all the Affordable Connectivity Program (“ACP”) services provided by NCC under the Federal ACP program at the date of this submission.

2. For those NCC ACP services that are not unbundled from its phone services, NCC applies the federal support before applying Kentucky Lifeline support.

3. Unlike the Emergency Broadband Benefit program, Affordable Connectivity Program providers may modify their available plans at any time. Should NCC choose to do so, it will prioritize the application of the state and federal lifeline credits consistent with the Commission’s February 21st Order.

4. NCC believes it is fully compliant with state and federal ACP requirements.
