In response to Commission Order Dated February 21, 2022, Peoples Rural Telephone Cooperative, Corp. and its wholly owned subsidiary, Peoples Telecom, LLC, (“PRTC”) responds as follows:

1. The list attached hereto as Attachment “A” identifies all the Affordable Connectivity Program (“ACP”) services provided by PRTC under the Federal ACP program at the date of this submission.
2. As of the date of this submission, all ACP services are billed on a standalone and unbundled basis from telephone services.
3. Unlike the Emergency Broadband Benefit program, Affordable Connectivity Program providers may modify their available plans at any time. Should PRTC choose to do so, it will prioritize the application of the state and federal lifeline credits consistent with the Commission’s February 21st Order.
4. PRTC believes it is fully compliant with state and federal ACP requirements.
