Attachment A provides the details of the Boomerang's ACP plan and reflects how state, federal and Affordable Connectivity support will be applied to eligible ACP Lifeline plans in Kentucky.

Boomerang Wireless will continue to seek Kentucky Universal Support Fund support for both the non-ACP subscribers on its existing Lifeline-only plan (Unlimited Talk & Text and 1 Gigabyte data) and for its ACP & Lifeline subscribers (Unlimited Talk & Text and 11 Gigabytes data).

If the KY USF \$6.00 subsidy is reduced or eliminated, the Lifeline subscriber will revert or downgrade to the Company's current free Lifeline non-tribal, voice minimum service standard plan offering available.
