In response to Commission Order Dated February 21, 2022, Cincinnati Bell Telephone Company, LLC (CBT, altafiber) responds as follows:

1. The list attached hereto as Attachment "A" identifies all the Affordable Connectivity Program (ACP) services provided by CBT under the Federal ACP program at the date of this submission.
2. For those CBT ACP services that are not unbundled from its phone services, CBT applies the federal support before applying the Kentucky Lifeline support.
3. Unlike the Emergency Broadband Benefit program, ACP providers may modify their available plans at any time. Should CBT choose to do so, it will prioritize the application of the state and federal lifeline credits consistent with the Commission's February 21st Order.
4. CBT believes it is fully compliant with state and federal ACP requirements.

One-Time Charges:

(1) A one-time Activation charge of \$39.99 applies to all new Internet service activations.

(2) A \$20 equipment shipping fee applies if customer chooses self-install and wants equipment shipped instead of picking it up at a retail location.

(3) A Professional Installation charge of \$130 applies to accounts eligible for self-install that request professional installation.

* The service is offered throughout the CBT serving area in Ohio, Kentucky and Indiana in areas where the company's broadband network is capable of supporting the applicable service offering. For example, the 250 Mbps plan is only available in areas served by FTTH facilities. CBT's non-ETC affiliate (CBET) offers Internet service in a limited area in Ohio contiguous to CBT's ILEC Ohio serving area.

** The \$5.00 E-bill discount (rebate) applies to customers who elect to receive an electronic bill in lieu of a paper bill and it is required to obtain some promotional rates.

*** Utility Surcharge is a monthly fee assessed on all accounts to cover the company's costs associated with Call Before You Dig (811) service requests, local utility infrastructure and operations.
