MOTION FOR EXTENSION OF TIME BY Q LINK WIRELESS, LLC, GLOBAL CONNECTION INC. OF AMERICA D/B/A STANDUP WIRELESS, AIRVOICE WIRELESS, LLC DBA FEEL SAFE WIRELESS, AMERIMEX COMMUNICATIONS CORP. DBA SAFETYNET WIRELESS, I-WIRELESS, LLC, DBA ACCESS WIRELESS AND SAGE TELECOM COMMUNICATIONS, LLC DBA TRUCONNECT

Q LINK Wireless, LLC, Global Connection Inc. of America dba StandUp Wireless, Airvoice Wireless, LLC dba Feel Safe Wireless, Amerimex Communications Corp. dba SafetyNet Wireless, i-wireless, LLC dba Access Wireless and Sage Telecom Communications, LLC dba TruConnect (together "Kentucky ETCs") hereby move for an extension of time until May 25, 2020 to submit its responses to the Kentucky Public Service Commission's ("Commission") request for information in the Order entered May 11, 2020 (the "Order"). In support of its Motion, the Kentucky ETCs state:
