Dear Ms. Bridwell:

Big Rivers Electric Corporation (“Big Rivers”) recently identified an error in its Economic Development Rate (“EDR”) Contract Report for 2023, which was filed on March 27, 2024. The error occurred when a “New Customer” was incorrectly classified as an “Existing Customer.” This mistake only affected the information presented in the format of Appendix A to the September 24, 1990, Order in Administrative Case No. 327. To correct this, Big Rivers is electronically filing an amendment, as outlined below along with its 2024 report.

Big Rivers is electronically filing the following materials:

1. this cover letter, which constitutes the Read1st file required by 807 KAR 5:001 Section 8(5);
2. the public version of Big Rivers’ EDR information as shown in Appendix A to the September 24, 1990, Order in Administrative Case No. 327 for the Calendar Year of 2023, with certain confidential information redacted;
3. the public version of Big Rivers’ Economic Development Rate Contract Report for the Calendar Year of 2024, pursuant to:
  - a. Findings 7 and 11 of the Commission’s September 24, 1990, Order in Administrative Case No. 327;<sup>1</sup>

- c. Ordering Paragraphs 5 and 7 of the Commission's October 14, 2021, Order in Case No. 2021-00282;<sup>3</sup> and
- d. Ordering Paragraphs 2 and 4 of the Commission's February 10, 2023, Order in Case No. 2023-00045,<sup>4</sup>

with certain confidential information redacted; and

- 4. a motion for confidential treatment of the confidential information in the reports (the "*Confidential Information*").
