4. What is the total amount of money that Columbia Gas of Kentucky, Inc. ratepayers, have contributed through voluntary donations to the WinterCare Energy Fund in each year 2013, 2014, 2015, and thus far in 2016?

5. What is the total amount of funding Columbia Gas of Kentucky, Inc. shareholders have contributed to Wintercare Energy Fund in each year 2013, 2014, 2015, and thus far in 2016.
6. What is the total amount of funding Columbia Gas of Kentucky, Inc. shareholders have contributed to Columbia's Energy Assistance Program in each year 2013, 2014, 2015, and 2016 ?
7. What is the total amount of ratepayer funding for Columbia Gas of Kentucky, Inc.'s Energy Assistance Program in each year 2013, 2014, 2015, and 2016?

12. Please provide the average monthly bill for residential customers of Columbia Gas of Kentucky, Inc. in each of the years 2013, 2014, 2015, and thus far in 2016?
