Hi Cheryl! Happy Friday!

I'm working with Walt Dozier at AdOhio on your quote for the Columbia Gas of Kentucky Hearing Notice. Attached is the revised quote which includes ad size, total cost for each newspaper and creative and space reservation deadlines.

There were two newspapers that had different net per column inch (PCI) costs which affected the overall cost of your placement. Lexington Herald-Leader had an initial PCI cost of \$52.18 (totaling \$156.54) but changed to \$42.81 (totaling \$128.43). Also, Mt. Sterling Advocate was \$6.88 per column inch (totaling \$20.64) but changed to \$9.97 per column inch (totaling \$29.91). With these changes, the total placement went from a total of \$1,082.61 to \$1,063.77.

Please take a look at the revised quote and let me know if you have any questions. I'll be happy to answer them for you!
