Accompanying this letter in electronic medium is a copy of the Expense Reduction Plan and Report of Cumberland Valley Electric, Inc. ("Cumberland Valley"), dated and verified this same date by Mr. Ted Hampton, Cumberland Valley's President and Chief Executive Officer. This filing is made in compliance with the Order entered by the Commission in the above-styled case on February 6, 2017, and specifically ordering paragraph number 6 thereof.

Pursuant to the Order, the leadership of Cumberland Valley has conducted an extensive, formal evaluation of the cooperative's expenses and, as a result, has identified a number of opportunities to implement cost reduction strategies. The document enclosed herewith details the processes employed by Cumberland Valley and summarizes the cooperative's plan to reduce its costs consistent with principles of prudent utility management. Included as part of the enclosed report/plan is a discussion of the advantages and disadvantages of a merger between Cumberland Valley and another electric utility, as required by the Commission in its Order of February 6, 2017.
