  - 1) How far down are we required to remove the existing column that supports the operating floor and walkways below? The abandoned side of the wet well is full of mud up to about elevation 461.00. Can we cut it of just below elevation 471.00 and leave the portion in place below that?
    - a) Removal of the pipe column can stop at elevation 471.0, and the lower portion can remain.
  - 2) Can you please provide shop drawings of the existing traveling screen?
    - a) A copy of the documents has been requested of the original manufacturer.


