

This letter transmits to you a copy of our General Water Quality Certification for Nationwide Permit # 3 for Maintenance. An individual Water Quality Certification is not necessary for this activity provided that this project has received the appropriate Nationwide Permit from the U.S. Army Corps of Engineers and all conditions of the attached General Water Quality Certification are met.

Although an Individual WQC is not needed, other permits from the Division of Water may be required. If this activity occurs within a floodplain, a Permit to Construct Across or Along a Stream may be required. Please contact the Floodplains Supervisor (502-782-6941) for more information. If the project will disturb one acre or more of land, or is part of a larger common plan of development or sale that will ultimately disturb one acre or more of land, a Kentucky Pollution Discharge Elimination System (KPDES) stormwater permit shall be required from the Surface Water Permits Branch. This permit requires the development of a Stormwater Pollution Prevention Plan (SWPPP). The SWPPP must include erosion prevention and sediment control measures.
