## <u>LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT</u> RESPONSE TO LG&E MOTION FOR LEAVE TO FILE SUR-REPLY

Comes now The Louisville/Jefferson County Metro Government ("Louisville Metro"), and objects to the Louisville Gas and Electric Company ("LG&E") Motion for Leave to File Sur-Reply. In support thereof, Louisville Metro states as follows:

No authority exists, nor was any claimed by LG&E, under which it may file a sur-reply. Deviations from the motion practice rules may occur, but only in "special cases, for good cause shown." Here, LG&E made no attempt to explain what special case or good cause exists. Indeed, Louisville Metro raised no new issues in its Reply that would warrant a sur-reply. In reality, Louisville Metro simply identified that LG&E has now made five (5) attempts to mislead the Commission regarding Louisville Metro's claims. In truth, Metro Louisville has never alleged that all LG&E gas customers should pay for the franchise fee through base rates. The simple act of identifying and highlighting the inaccuracy of LG&E's statement does not create a new issue, a special case, or a good cause to justify LG&E filing a sur-reply.
