DISCOVERY STATUS REPORT OF LOUISVILLE GAS AND ELECTRIC COMPANY

Louisville Gas and Electric Company ("LG&E" or "Company") hereby files its discovery status report with the Kentucky Public Service Commission ("Commission").

On May 18, 2017, LG&E and Louisville/Jefferson County Metro Government ("Louisville Metro") held a phone conference to discuss informal resolution of the discovery dispute. The parties discussed the information that Louisville Metro sought to obtain and LG&E's ability to produce the information. LG&E explained that the historical network analysis results that Louisville Metro requested are not available. LG&E offered to instead create a map using design day data, which was acceptable to Louisville Metro.

The parties agreed that LG&E will file this map as a supplemental response to Question No. 1 of Louisville Metro's Request for Information by Friday, May 26, 2017. The map will show LG&E's high pressure transmission pipelines in Jefferson County and all distribution pipelines (excluding service lines) of any pressure crossing the Jefferson County line. LG&E will also add the design day direction of flow and flow volumes to the map. Louisville Metro stated that this supplemental response addresses its concerns with LG&E's responses to Question Nos. 1 and 12.
