JOINT MOTION REQUESTING REBUTTAL TESTIMONY DEADLINE

Louisville Gas and Electric Company (“LG&E”) and Louisville/Jefferson County Metro Government (“Louisville Metro”) (“Joint Movants”) hereby move the Kentucky Public Service Commission (“Commission”) to establish a deadline to file rebuttal testimony of June 16, 2017.

On April 20, 2017, Louisville Metro filed a motion requesting the Commission compel LG&E to respond to Question Nos. 1 and 12 of Louisville Metro’s request for information. Louisville Metro also requested a suspension of the procedural schedule contained in the Commission’s February 27, 2017 Order requiring each party to file rebuttal testimony by April 21, 2017. By Order dated April 21, 2017, the Commission suspended the procedural schedule’s due date for filing rebuttal testimony and stated that a new due date would be established by further order of the Commission.

Following the filing of a supplemental response by LG&E on May 26, 2017, LG&E and Louisville Metro have resolved the discovery dispute and are now ready to resume the procedural schedule. Counsel for LG&E has conferred with counsel for Louisville Metro about a mutually acceptable due date for the rebuttal testimony. The Joint Movants agree that June 16, 2017 is an appropriate due date for filing rebuttal testimony.

WHEREFORE, Louisville Gas and Electric Company and Louisville/Jefferson County Metro Government respectfully request the Commission enter an order establishing a June 16, 2017 deadline to file rebuttal testimony.


