**DISCOVERY STATUS REPORT OF
LOUISVILLE GAS AND ELECTRIC COMPANY**

Louisville Gas and Electric Company (“LG&E” or “Company”) hereby files its discovery status report with the Kentucky Public Service Commission (“Commission”). On March 24, 2017, Louisville/Jefferson County Metro Government (“Louisville Metro”) filed its Request for Information to LG&E in the above-captioned proceeding and on April 7, 2017, LG&E filed its Response. On April 20, 2017, Louisville Metro filed its Motion to Compel, and on April 27, 2017, LG&E filed a response to the Motion to Compel indicating that LG&E was attempting to informally resolve the discovery dispute with Louisville Metro.

On May 4, 2017, the Commission ordered LG&E to file a status report of the parties’ efforts to resolve the discovery dispute on or before May 15, 2017. The parties have scheduled a phone conference to discuss the discovery dispute on May 18, 2017, at 9:30 a.m, which is the first mutually convenient time for the parties. After the phone conference, LG&E will notify the Commission within two business days whether the parties are able to informally resolve the discovery dispute. If the parties are unable to informally resolve the discovery dispute, LG&E will file a substantive response to Louisville Metro’s Motion to Compel no later than seven days after notifying the Commission that the discovery dispute cannot be resolved.


