MOTION TO INTERVENE OF THE KENTUCKY CABLE TELECOMMUNICATIONS ASSOCIATION

Pursuant to K.R.S. § 278.310 and 807 K.A.R 5:001, Section 4(11), the Kentucky Cable Telecommunications Association ("KCTA") respectfully requests the Public Service Commission to permit it to intervene and become a party in the above-captioned proceeding. In support of its Motion to Intervene ("Motion"), KCTA states as follows:

- 1. On November 23, 2016, Kentucky Utilities Company ("KU") filed an Application seeking approval for adjustment of its electric rates, as well as Certificates of Necessity for deployment of Advanced Metering Systems and its Distribution Automation Project and other requests for relief ("Application").
- 2. KCTA is a non-profit organization consisting of cable operators serving the majority of cable customers throughout Kentucky. Several KCTA members, including Charter Communications, Inc., attach their facilities to KU's utility poles, and are directly affected by multiple aspects of KU's Application. KCTA's members are directly impacted by KU's proposed modifications to its pole attachment rates, terms, and conditions, including rates, terms, and conditions related to wireless facilities. KU's proposed installation of a remote wireless metering system further impacts KCTA's members' existing facilities on KU's poles and their use of excess space on KU's poles. KCTA members like Charter Communications, Inc. also

purchase significant amounts of electricity from KU, and thus modifications to KU's rates therefore impact the operations of KCTA members.

- 3. Accordingly, KCTA's members have a direct and substantial interest in the outcome of this proceeding. KCTA's intervention is in lieu of the individual intervention of its affected members. Consequently, KCTA's intervention will promote the timely and efficient progress of this proceeding by reducing the burden on other parties and on the Commission. KCTA's intervention also will allow the interests of KCTA's members to be represented without the burden of each member being required to retain its own counsel, participate individually in the proceedings, and make its own filings. KCTA's participation in this case is likely to present issues and develop facts that will assist the Commission in fully considering the matter.
