# JOINT MOTION OF KENTUCKY UTILITIES COMPANY AND LOUISVILLE GAS AND ELECTRIC COMPANY FOR AN INFORMAL CONFERENCE

Kentucky Utilities Company ("KU") and Louisville Gas and Electric Company ("LG&E") (collectively, the "Companies") respectfully move the Kentucky Public Service Commission ("Commission") to schedule an informal conference in these proceedings on or before March 31, 2016 for the purpose of discussing with Commission Staff and Commissioners and all parties to the cases the procedures for conducting settlement discussions and the Commission's review of any resulting settlement agreements or stipulations.

On January 27, 2017, at the Kentucky Chamber Energy Management Conference during the panel discussion titled "Inside the Public Service Commission" the Commissioners expressed to the audience their concerns with the settlement process and reviewing black-box types of settlement agreements. The Companies desire to understand those concerns more clearly and

discuss what if any procedures can be undertaken to more fully address the Commission's

concerns.

The purpose of the requested informal conference is not to engage in any substantive

discussion of or possible compromise on the issues in these cases. The Companies are in the

process of preparing their rebuttal testimony due April 14, 2017. The Companies may request

the Commission to schedule a separate informal conference for a date after their rebuttal

testimony is filed for the purpose of discussing the substantive issues and possible compromise

and settlement with the parties to the cases and Commission Staff.

The Companies are willing to provide a conference call dial-in number for parties

wishing to participate by telephone.

WHEREFORE, KU and LG&E respectfully ask the Commission to schedule an

informal conference in these proceedings for the purpose of discussing procedures for settlement

discussions and the review of any settlement or stipulation resulting from such discussions on or

before March 31, 2016.
