**JOINT MOTION**

Kentucky Utilities Company (“KU”) and Louisville Gas and Electric Company (“LG&E”) (collectively “Companies”) hereby respectfully move for leave to file the written Second Stipulation and Recommendation (“Second Stipulation”) entered into by the Companies, BellSouth Telecommunications, LLC d/b/a AT&T Kentucky (“AT&T”) and Kentucky Cable Telecommunications Association (“KCTA”) (collectively “Stipulating Parties”).

As grounds for their motion, the Companies state that the Stipulating Parties and Commission Staff attended an informal conference at the Commission’s offices on April 12, 13 and 25, 2017, to discuss settlement of the issues associated with the Companies’ proposed *Pole and Structure Attachment Rate (“PSA”) Schedule*. As a result of this informal conference, the Stipulating Parties have reached a settlement of all the issues associated with the *PSA Schedule* and have documented their understanding in the Second Stipulation.

**WHEREFORE**, KU and LG&E request the Commission enter an order granting the Companies leave to file the Second Stipulation in the records for these proceedings.


