
**AFFIDAVIT OF HOLLAND N. "QUINT" MCTYEIRE V**

Affiant, Holland N. ("Quint") McTyeire V, after being first duly sworn, states:

1. I am one of the counsel for Bullitt Utilities, Inc. ("BU") in this matter.
2. On November 30, 2016, BU provided a copy of the Notice required by 807 KAR 5:011 Section 8(1)(a) and a complete copy of this Surcharge Application to Jeanie Tinnell, the BCSD's Office Manager.
3. I asked Ms. Tinnell to post the Notice in the BCSD's place of business as the Receiver for BU while the Surcharge Application is pending. A copy of my November 30, 2016 letter to Ms. Tinnell which included the Notice is attached.
4. I also asked Ms. Tinnell to make the copy of BU's Surcharge Application available for review if so requested.
5. I spoke to Ms. Tinnell on November 30, 2016 about the requests in my letter and she was very helpful and willing to assist me.
6. The Notice attached to my letter to Ms. Tinnell was mailed to all of BU's customers on November 28, 2016.
7. We used the Customer List attached to this Affidavit for the mailing to BU's customers. We redacted the column with the Customer Names from the attached Customer List to comply with 807 KAR 5:001 Section 4(10).

8. We received the Customer List from the Louisville Water Company (the “LWC”), BU’s Billing and Collection Agent, in two Excel Spreadsheets on November 17, 2016, one for BU’s Blue Lick customers and one for BU’s Hunters Hollow customers.
9. We generated mailing labels from the Excel Spreadsheets for the November 28, 2016 mailing to BU’s customers. We combined the two Spreadsheets provided by the LWC into one document for this filing with the Commission.
10. Only five of the about 700 Notices sent to BU’s customers were returned. We verified that we had used the correct addresses provided by the LWC. We resent the five returned envelopes to the “Current Resident” in the hope that if those five returned envelopes represent current BU customers, those customers would receive notice of BU’s Surcharge Application.
11. We believe BU has complied with all of the Commission’s rules and regulations relating to providing notice of BU’s Surcharge Application.
