MOTION OF BU FOR AN EXTENSION OF TIME TO FILE ITS RESPONSE TO THE DEFICIENCIES IDENTIFIED IN THE COMMISSION'S DECEMBER 29, 2016 ORDER

Bullitt Utilities, Inc. ("BU"), by Robert W. Keats, Chapter 7 Trustee for BU (the "Trustee"), files this Motion for an Extension of Time to respond to the deficiencies with BU's Surcharge Application identified in the Commission's December 29, 2016 Order. 5 BU is only requesting an additional four days for filing its Response and there has been no Procedural Schedule set so no party will be prejudiced by granting this Motion. For the reasons above, BU's Motion for an Extension of Time to respond to the

deficiencies should be granted and BU given until January 13, 2017 to respond.
