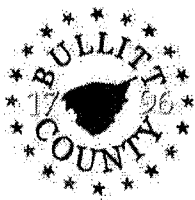

**RE: BULLITT UTILITIES, INC./HUNTER'S HOLLOW SEWER SYSTEM
BULLITT COUNTY SANITATION DISTRICT**

Dear Hon. McTyeire,

Please allow this to serve as further follow up and response to your correspondence dated October 26, 2016. We appreciate the continued efforts of all parties involved to work towards amicable resolution of any and all issues in this matter. As previously discussed, the Bullitt County Sanitation District ("BCSD") will not actively oppose any application for a surcharge by the Trustee, but cannot expressly support such surcharge application in light of its duties to its customers and its responsibilities as appointed Receiver. BCSD will remain neutral with respect to any surcharge application for the benefit of creditors to Bullitt Utilities.

Trustee Robert Keats has previously expressed the possibility that a portion of any surcharge application could be sought for the purpose of covering operational/administrative expenses of the Hunter's Hollow System. BCSD has expressed its support for any surcharge for this purpose. Regardless, BCSD will provide factual information and testimony as needed and required as to the current physical and financial condition of the Hunter's Hollow System, and its experiences and actions as Receiver pursuant to any surcharge application.

BCSD has already forwarded information under separate cover to you in response to items #2-7 requested in your correspondence. Upon your review, please advise if BCSD can provide any further assistance.

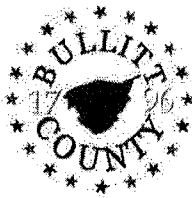

With respect to the filing of the 2015 Annual Report for Bullitt Utilities, we have contacted the Kentucky Public Service Commission for their opinion as to the filing requirement and the appropriate party responsible in light of the abandonment by Bullitt Utilities, the appointment of BCSD as Receiver, and the filing of the involuntary bankruptcy. We are still awaiting a response from PSC. Regardless, BCSD is not in a position to file any report on behalf of Bullitt Utilities that covers any period prior to its appointment as Receiver in September 2015. BCSD cannot verify the information required for the filing of any such report, and it does not possess information as to the business structure, finances, etc. of Bullitt Utilities in order to file any such report. Further, the filing of an Annual Report for Bullitt Utilities would most likely require the expenditure of significant monies to secure audited financial statements, and BCSD is not in a position, nor is obligated to expend said monies. Once we have a response from PSC, we hope to have more clarification on this issue.

Thank you for your continued consideration and cooperation. We look forward to continuing to work to bring these matters to a close. Please do not hesitate to contact me with any questions or concerns.
