transmitted to the Commission on December 29, 2016; that there are currently no parties in this proceeding that the Commission has excused from participation by electronic means; and that the original in paper medium of this filing will be filed by hand-delivery with the Commission within two business days from the date of the electronic filing.

The revised tariff sheets set forth a Gas Supply Cost Component of 42.950 cents per 100 cubic feet applicable to all gas sold during the period of February 1, 2017 through April 30, 2017. In addition, we file herewith a corresponding number of copies of "Supporting Calculations for the Gas Supply Clause."

Also enclosed herewith is a summary of our gas service rates effective for the period of February 1, 2017 through April 30, 2017.

Furthermore, we are filing a petition to seek confidentiality with respect to the names of natural gas suppliers otherwise shown on Exhibit B-1, Pages 6 of 7 and 7 of 7.

This filing represents expected gas costs for the three-month period February 1, 2017 through April 30, 2017. The Gas Cost Actual Adjustment (GCAA) and the Gas Cost Balance Adjustment (GCBA) levels are changed from the levels that were implemented on November 1, 2016. These adjustment levels will remain in effect from February 1, 2017 through April 30, 2017.

We respectfully request your acceptance of this filing which we believe is in full compliance with the provisions of the LG&E Gas Supply Clause approved by the Kentucky Public Service Commission.
