MOTION FOR EXTENSION OF TIME

Southern Water and Sewer District (the “Southern District”), Prestonsburg City’s Utilities Commission (the “PCUC”), and the City of Prestonsburg, Kentucky (the “City”) (collectively the “Joint Applicants”) hereby move the Kentucky Public Service Commission (the “Commission”) for an extension of time through and until Tuesday, April 25, 2017, in which to file responses to the Commission Staff’s Second Request for Information dated April 6, 2017. In support of their motion, the Joint Applicants state:

1. Question 1(c) of the Commission Staff’s Second Request for Information requests the journal entries that Southern District will record upon completion of the transfer of assets. Southern District has no employee capable of providing the journal entries. Southern District relies upon Jeff Reed, a CPA at the

Michael Spears accounting firm in Prestonsburg, for its bookkeeping services. Mr. Reed is very busy preparing income tax returns through the deadline on Tuesday, April 18, 2017. After the income tax deadline, Mr. Spears will be out of the office for the remainder of the week. The requested extension of time through Tuesday, April 25, 2017, would allow Mr. Spears two days after he returns to the office to prepare the requested journal entries for Southern District.


2. The Joint Applicants withdraw their request for the Commission to render a decision by April 21, 2017, and instead request a decision by May 12, 2017. The Closing, which was tentatively scheduled for May 1, 2017, will be postponed until the receipt of an Order from the Commission approving the transfer of ownership.

3. This Motion for Extension of Time is not made for the purpose of unduly delaying the Commission's examination and, if granted, will not prejudice the Commission's ability to conduct its examination.

WHEREFORE, the Joint Applicants respectfully request that the Commission issue an order granting an extension of time through and until Tuesday, April 25, 2017, to file responses to the Commission Staff's Second Request for Information.
