MOTION TO SUBSTITUTE EXHIBIT

Monroe County Water District (“Monroe District”) moves for the Commission to substitute a revised version of Expected Exhibit 17 for the version electronically filed with the Commission on September 20-21, 2017. In support of its motion, Monroe District states:

1. In its filing on September 20-21, 2017, Monroe District erroneously filed a complete version of “Wage and Salary Survey of Kentucky Cities” (2016 edition) as Expected Exhibit 17 with its List of Expected Witnesses and Exhibits and a copy of its expected exhibits.

2. Monroe District intended to submit only excerpts from the publication, not the complete publication. Its counsel erroneously inserted a copy of the entire document into the electronic version submitted to the Commission on September 20-21, 2017 instead of an excerpted version. The excerpts are the only portions of the publication that Monroe District expects to present as an exhibit at the scheduled hearing.

3. Prior to making its filing, Monroe District represented to the Kentucky League of Cities – the document’s publisher - that it would use only limited excerpts from the publication as the publication is generally made available only to the publisher’s members.

4. Monroe District has included with the electronic version of this motion a revised version of the portable document format file containing Exhibits 1 - 17. With the exception of Exhibit 17, all of the exhibits in this file are exactly the same as that electronically filed with the


Commission on September 20-21. Exhibit 17 is the excerpted version of the publication, not the complete version.

5. When Monroe District submits its six copies of the Expected Exhibits in paper medium to the Commission on September 22, 2017 to satisfy the requirements of the Commission's Orders of August 18, 2017 and September 18, 2017, Monroe District's submission will contain the excerpted version of "Wage and Salary Survey of Kentucky Cities," not the complete publication.

WHEREFORE, Monroe District requests that the Commission permit the substitution of the revised electronic version of Expected Exhibit 17 for that previously filed with the Commission and permit to Monroe District to submit the revised version of Exhibit 17 in paper medium to satisfy the requirements of the Commission's Orders of August 18, 2017 and September 18, 2017.
