transmitted to the Commission on March 31 2017; that there are currently no parties in this proceeding that the Commission has excused from participation by electronic means; and that the original in paper medium of this filing will be filed by hand-delivery with the Commission within two business days from the date of the electronic filing.

The revised tariff sheets set forth a Gas Supply Cost Component of 44.310 cents per 100 cubic feet applicable to all gas sold during the period of May 1, 2017 through July 31, 2017. In addition, we file herewith a corresponding number of copies of "Supporting Calculations for the Gas Supply Clause."

Also enclosed herewith is a summary of our gas service rates effective for the period of May 1, 2017 through July 31, 2017.

Furthermore, we are filing a petition to seek confidentiality with respect to the names of natural gas suppliers otherwise shown on Exhibit B-1, Pages 6 of 7 and 7 of 7.

This filing represents expected gas costs for the three-month period May 1, 2017 through July 31, 2017. The Gas Cost Actual Adjustment (GCAA) and the Gas Cost Balance Adjustment (GCBA) levels are changed from the levels that were implemented on February 1, 2017. These adjustment levels will remain in effect from May 1, 2017 through July 31, 2017.

We respectfully request your acceptance of this filing which we believe is in full compliance with the provisions of the LG&E Gas Supply Clause approved by the Kentucky Public Service Commission.
