Mr. Humphries,

Good afternoon. As discussed in our phone conversation, the referenced project is at Public Service Commission for review and they had a question on DOW approval. My notes stated that "DOW construction permit is not required as the project is considered maintenance. Project does not include any expansion to plant facilities. Equipment replacement only." The project includes the replacement of an existing, outdated belt filter press and polymer feed system with a new belt filter press and polymer feed system. The specification of the proposed systems match the specifications of the existing systems. The existing equipment is just outdated and proven to be troublesome to operators. Additionally, the project includes some building modifications that have been approved by Building Code and Division of Plumbing.

Please see the attached plans sheets for the demolition plan and proposed work plan. If you could please respond back to this email verifying that a DOW construction permit is not required as the project is considered maintenance, that would be appreciated.
