ATTORNEY GENERAL'S MOTION TO WITHDRAW FILING AND SUBSTITUTE WITH CORRECT FILING

Comes now the intervenor, the Attorney General of the Commonwealth of Kentucky, by and through his Office of Rate Intervention, and hereby moves the Commission for leave to withdraw the filing he submitted into the docket of this matter on May 8, 2018, and substitute it with the filing accompanying this motion.

In support of this motion, counsel states that on May 8, 2018 he inadvertently uploaded his previously-filed Initial Data Requests in this matter, instead of the Supplemental Data Requests which he had prepared for filing on the same date. Upon discovering this errant filing on May 9, 2018, counsel for the Attorney General provided counsel for Kentucky Power Co. ("KPCo") with the correct set of data requests, and represented that the Attorney General would not object if KPCo requires an additional day in which to file responses to the Attorney General's Supplemental Data Requests. Since these Supplemental Data Requests were addressed solely to KPCo, and since only one day has transpired since learning of the errant filing, the Attorney General does not believe the handling of this matter will be prejudiced in

any matter by granting his motion. Finally, counsel for KPCo has authorized the foregoing counsel to represent that he will not object to the Attorney General's instant motion.

WHEREFORE, the Attorney General respectfully requests that the Commission grant his motion.
