Motion For Leave To Deviate

Kentucky Power Company moves the Public Service Commission of Kentucky pursuant to 807 KAR 5:001, Section 22 for leave to deviate with respect to certain voluminous documents from the requirement in the Commission's April 27, 2017 order that it file with the Commission an original and six copies in paper medium of all documents filed electronically in this case.

**Documents For Which Leave Is Sought To File Original
And Six Copies On Compact Disc**

Kentucky Power seeks leave to file on compact disc in lieu of the required paper original and six paper copies of its 2014 and 2015 federal and state tax returns filed herein by agreement with the Attorney General in response to AG 1-115 and AG 1-158. The originals of these returns total over 3,500 pages. An original and six copies of the returns provided in paper medium would measure over eleven feet in height. Providing the original and six copies in electronic format is more efficient and should not impede review of the Company's application.

Further, Kentucky Power has also agreed with the Attorney General to file its 2016 federal and state tax returns herein when they are available. Kentucky Power anticipates that its 2016 returns will be as voluminous as its 2014 and 2015 returns. Therefore, Kentucky Power

also requests that it be granted leave to file an original and six copies of its 2016 federal and state tax returns on compact disc in lieu of the required paper original and six paper copies when they become available.

Wherefore Kentucky Power Company respectfully requests that the Commission enter an Order:

1. Granting the Company's motion for leave to deviate from the Commission's April 27, 2017 order in this case by filing the required original and six copies of its 2014 and 2015 federal and state tax returns on compact disc in lieu of paper format;
2. Granting the Company's motion for leave to deviate from the Commission's April 27, 2017 order in this case by filing the required original and six copies of its 2016 federal and state tax returns on compact disc in lieu of paper format when they become available; and
3. Granting such further relief to which the Company may be entitled.
