

Kentucky Power Company's Notice Regarding Ordering Paragraph 13
Of The Commission's January 18, 2018 Order

Kentucky Power Company notifies the Public Service Commission of Kentucky that in conformity with ordering paragraph 13 of the Commission's January 18, 2018 Order in this matter the Company notified all of its more than 2,000 GS class customers whose average monthly demand is 25 kW or greater that Tariff GS had been modified. The notification was by a letter mailed on or before April 6, 2018. A form of the letter is attached.

Kentucky Power provided the notified customers with a toll-free number that the customers could call to discuss the effect of the changes, as well as other tariff options. In addition, Kentucky Power will contact each such customer by telephone to discuss the effect of the changes and other tariff options.
