JOINT REPORT REGARDING SCHEDULE

On September 18, 2017, this Court ordered the parties to develop jointly a proposed schedule for the above-captioned action in the wake of the Sixth Circuit’s opinion and the lifting of the motion to stay this action. Below please find a proposed schedule for the case on which the parties have agreed:

Fact Discovery	April 20, 2018
Expert Initial Disclosures	May 2, 2018
Expert Rebuttal Disclosures	June 15, 2018
Discovery Cut-Off	July 13, 2018
Dispositive Motions	August 3, 2018

On September 19, 2017, the Court agreed to stay “the deadlines for compliance with or objecting to the Court’s March 7, 2016 and March 28, 2016 Opinions and Orders (ECF Nos. 204, 215)” and “ordered that the parties also propose deadlines for compliance with or filing

objections to these Opinions and Orders.” ECF No. 235. The parties have conferred regarding these deadlines.

The parties propose that the existing stay of the deadline for objecting to the Opinions and Orders should (1) expressly be made retroactive to July 6, 2017, and (2) be lifted effective seven days after entry of a scheduling Order in this case, giving the parties 21 days from the entry of the scheduling Order to submit to Chief Judge Sargus any objections regarding the Court’s March 7, 2016 and March 28, 2016 Opinions and Orders (ECF Nos. 204, 215). The parties propose that the deadlines for compliance with the Court’s March 7, 2016 and March 28, 2016 Opinions and Orders shall be stayed pending the later of (1) the expiration of the 21-day period to submit objections or (2) the disposition of any objections timely filed with Chief Judge Sargus.
