**NOTICE OF FILING**

Kentucky Power Company provides notice of the filing of the following documents:

(1) An updated and amended version of the testimony of Matthew J. Satterwhite in Support of the Settlement Agreement. The updated and amended version of Company Witness Satterwhite's testimony makes the following changes:

(a) it corrects a typographical error on page S4, line 10, to confirm that the Settlement Agreement represents give and take among all the Signatory Parties;

(b) it removes footnote (1) from page S4 due to Kentucky Cable Television Association providing an executed signature page;

(c) it updates on page S15, lines 1 and 2, the Company's forecasted increase in PJM OATT LSE expenses in 2018 based on a revised filing with PJM;

(d) it corrects typographical errors on page S18, line 22, and page S19, line 1, regarding the remaining unamortized balance of the existing storm damage regulatory asset authorized in Case No. 2012-00445, and the annual amortization amount over the proposed five year period;

(e) it adds an inadvertently omitted word to page S20, line 14, to clarify that if an agreement on backup and maintenance service cannot be reached within 120 days, then the issue may be presented to the Commission; and

(f) it describes on pages S23 and S24 changes made following additional communication with Kentucky Cable Telecommunications Association to the structure and amount of pole attachment rate under Tariff C.A.T.V.

(2) An updated version of the Settlement Agreement, Exhibit MJS-1S, to include revised rates for pole attachments under Tariff C.A.T.V. in Paragraph 16(c), and an executed signature page from the Kentucky Cable Telecommunications Association.

(3) Copies of Exhibits AEV-3S and AEV-4S in Microsoft Excel format. The Company previously provided these documents to counsel for the Attorney General in response to a specific request.
