**CITY OF CENTRAL CITY’S
PETITION FOR CONFIDENTIAL PROTECTION**

The City of Central City (“Central City”), by counsel, hereby petitions the Kentucky Public Service Commission (“Commission”) pursuant to 807 KAR 5:001, Section 13 and KRS 61.878(1) to grant confidential protection for portions of documents produced as a supplemental response to Item 10 of the Commission Staff’s First Request for Information, as filed on August 11, 2017. In support of its petition, Central City states as follows:

Administrative Regulation 807 KAR 5:001, Section 13, indicates that the Commission shall grant confidential treatment for records that would be exempt from KRS 61.878 of the Kentucky Open Records Act. KRS 61.878(1)(a) protects information of a personal nature from being disclosed by a public agency.

Item 10 of the Commission Staff’s First Request for Information seeks certain information related to the insurance benefits received by Central City employees, as well as type of insurance plans and premiums paid by employees. This is clearly the type of information that “would constitute a clearly unwarranted invasion of personal privacy” and, therefore, exempt under KRS 61.878(1)(a). By disclosing the type of insurance certain employees choose,

individuals can learn the marital status and whether an employee has children. Likewise, the disclosure of premiums paid by employees is no different than exempted information on a payroll voucher. These issues were directly addressed in an Attorney General's Opinion involving Owensboro Municipal Utilities, in which the Attorney General found that those items were exempt from disclosure pursuant to the Open Records Act. See 07-ORD-056 (Apr. 10, 2007), *available at* 2007 WL 1231570.

Accordingly, Central City requests confidential treatment of information mentioned above in perpetuity, as this information is no less personal through the passage of time.
