## Re: <u>WILLIAM C. HILL v. MUHLENBERG COUNTY WATER DISTRICT</u> Case No. 2017-00316 – Comments to Informal Conference Memorandum

**Executive Director Pinson:** 

Following the Informal Conference held in the above-styled matter on February 7, 2018, a memorandum summarizing the discussions that took place was filed of record on March 2, 2018. Mr. Hill, the complainant, hereby submits a brief clarifying comment upon the content of that memorandum, specifically the statement on Page 2 thereof that "[t]he parties agreed that Todd County [Water District] needs to be a party to this action."

Mr. Hill's position with respect to the introduction of Todd County Water District to this proceeding is deferential – if the Commission believes that Todd District's participation is necessary in order for Mr. Hill to obtain complete and appropriate relief or to otherwise resolve this dispute, he does not intend to object. However, as a resident of Muhlenberg County whose developments for decades have benefited Muhlenberg County and its Water District, and who has been in discussions with Muhlenberg County Water District *for years* to obtain appropriate service for the subject property in Muhlenberg County, Mr. Hill believes the relief he seeks is warranted based on his Complaint as pled. Ultimately, Mr. Hill's primary goal is clean, adequate water, and he hopes that territorial issues and finger-pointing are not permitted to overcome this proceeding and result in further unnecessary delay.
