MOTION FOR EXTENSION OF TIME

Muhlenberg County Water District (“Muhlenberg District”) hereby moves the Kentucky Public Service Commission (“Commission”) for an extension of time through and until Thursday, June 28, 2018, in which to file a map depicting the route it proposes for a water line to provide water to complainant’s residence and proposed subdivision as requested by the Commission’s order dated May 31, 2018.

The requested extension of time is necessary for Muhlenberg District to provide a complete and thorough map in response to the Commission’s Order dated May 31, 2018. Muhlenberg District has engaged an engineering firm to create this map. In addition, Muhlenberg District’s counsel has been busy preparing for a Formal Hearing before the Commission and drafting a brief and responses to Requests for Information in Case No. 2017-00417. Muhlenberg

District will file the map with the Commission after it has received and reviewed the map.

In the meantime, Muhlenberg District files the attached map which depicts (in blue) Todd County Water District's ("Todd District") existing water lines, which includes a 3-inch line near Mr. Hill's property. Todd District's water line terminates approximately 400 feet before it meets Mr. Hill's driveway.



Muhlenberg District's requested extension of time will allow the Commission and Mr. Hill one week to review the requested map prior to the formal prehearing conference.
