**RESPONSE OF MUHLENBERG COUNTY WATER DISTRICT TO
MOTION FOR PROCEDURAL SCHEDULE**

Pursuant to 807 KAR 5:001, Section 5(2), Muhlenberg County Water District (“Muhlenberg District”) hereby responds to William C. Hill’s Motion for Procedural Schedule filed with the Kentucky Public Service Commission (“Commission”) on January 17, 2018. In support of its Response, Muhlenberg District states as follows:

Mr. Hill’s Motion requests the establishment of a procedural schedule for the expeditious handling of this matter. Muhlenberg District does not oppose the establishment of a procedural schedule.

Mr. Hill also requests the “Commission schedule a hearing to resolve all issues at the earliest possible date.” Scheduling a hearing in this matter would be

premature and result in all parties expending unnecessary time and resources to resolve this matter. Muhlenberg District instead believes an informal conference would best allow the parties to resolve all issues in an expedient manner. Muhlenberg District understands that Commission Staff is in the process of scheduling an informal conference in this matter.


WHEREFORE, for all the reasons set forth above, Muhlenberg District respectfully requests the Commission:
