**DUKE ENERGY KENTUCKY, INC.'S

Comes now Duke Energy Kentucky, Inc. (Duke Energy Kentucky), by counsel, and respectfully gives notice of its willingness and desire to submit the case on the administrative record for a final decision, respectfully stating as follows:

The Commission entered its Order in this case on April 13, 2018. Petitions for Rehearing were thereafter filed by Duke Energy Kentucky, the Attorney General (AG) and the Kentucky School Boards Association (KSBA). In Orders entered on May 18, 2018 and May 23, 2018, the Commission denied KSBA's Petition for Rehearing and granted in part and denied in part the Petitions for Rehearing filed by Duke Energy Kentucky and the AG. The Commission entered a Scheduling Order on May 31, 2018 which provided for two rounds of information requests and the opportunity for any party to request a hearing on or before August 13, 2018.

Duke Energy Kentucky does not believe there is a need to hold an evidentiary hearing on the issues presented in the rehearing phase of this proceeding and hereby tenders notice of its

willingness and desire to submit the case on the administrative record for a final decision. However, should any other party request an evidentiary hearing to be held, Duke Energy Kentucky reserves all rights, claims, defenses and arguments which it might present therein.

WHEREFORE, Duke Energy Kentucky respectfully gives notice of its willingness and desire to submit the case on the administrative record for a final decision.
