**Motion To Cancel Hearing And For Leave
To Dismiss Without Prejudice The Pending Rehearing**

Kentucky Power Company moves the Public Service Commission of Kentucky to cancel the November 27, 2018 hearing in this matter and for leave to dismiss without prejudice the pending rehearing in this matter. Kentucky Power states in support:

1. The Commission on March 16, 2018 entered its order granting in part and denying in part the Company's application for a certificate of public convenience and necessity to construct the Hazard-Wooton 161 kV Transmission Line project.
2. Kentucky Power subsequently filed a motion seeking partial rehearing or clarification of the March 16, 2018 order with respect to three issues. The Commission on April 25, 2018 entered its order granting Kentucky Power's motion for partial rehearing and clarification and establishing a procedural schedule on rehearing.
3. Rehearing currently is scheduled for November 27, 2018.
4. The Commission entered its order dated November 14, 2018 denying Kentucky Power's request for an informal conference and for leave to modify the order of examination at the November 27, 2018 hearing.

5. The Commission's November 14, 2018 order modified ordering paragraph 2 of the March 16, 2018 order to grant the Company authority "to construct the Hazard-Jackson 69 kV reconfiguration...."¹

6. The Commission's November 14, 2018 order further provides:

The Commission notes that, while we denied the CPCN for the Supplemental Project because Kentucky Power failed to meet its burden of proof by presenting evidence to support its request, we did not foreclose a future proceeding because we did not deny the CPCN with prejudice.²

7. Based on the Commission's modification of ordering paragraph 2, and the guidance provided concerning the Company's ability to initiate a future proceeding because the Commission "did not deny the CPCN with prejudice," Kentucky Power respectfully requests leave to dismiss without prejudice the pending rehearing in this matter and to cancel the scheduled November 27, 2018.

8. Further based on the Commission's November 14, 2018 order, Kentucky Power respectfully informs the Commission that it anticipates it will initiate a future proceeding concerning the remaining project elements by filing a new application.

Wherefore, Kentucky Power Company respectfully requests the Commission enter an order:


1. Granting Kentucky Power's motion to cancel the November 27, 2018 hearing scheduled in this matter;
2. Dismissing without prejudice the pending rehearing; and
