MOTION FOR CONFERENCE WITH COMMISSION STAFF

Pursuant to 807 KAR 5:001, Section 9(4), Commercial Propane Service LLC ("CPS"), by counsel, moves for a conference with Commission Staff to discuss the possibility of settlement in this matter through the use of an alternative method of rate regulation. Given its small size and the unique nature of its operation, CPS believes that the use of an alternative method of regulation similar to that authorized in Case No. 2013-00076² may provide a more effective, efficient, and less costly means for the Commission to regulate CPS's rates and to protect the interests of CPS's customers. Prior to CPS incurring any additional expense in prosecuting its application, it wishes to discuss such method of alternative rate regulation with Commission Staff.

CPS requests that a conference be held during the week of March 5 or March 12. Counsel for CPS will provide by electronic mail to the Commission Staff counsel assigned to this matter a list of dates and times that CPS's representatives are available appear or otherwise participate in a conference with Commission Staff to facilitate the selection of a date and time for the requested conference. CPS will also provide Commission Staff counsel a written description of its proposal in advance of the conference.
