## ATTORNEY GENERAL'S MOTION TO LATE-FILE HIS POST-HEARING BRIEF

Comes now the intervenor, the Attorney General of the Commonwealth of Kentucky, by and through his Office of Rate Intervention, and hereby moves the Commission for leave to late-file his post-hearing brief in the above-styled matter. In support of this motion, the Attorney General states as follows.

On March 28, 2018 Commission Staff issued post-hearing data requests to both Atmos Energy Corporation ["Atmos"] and the Attorney General in this matter. On April 6, 2018 both parties field their respective responses to these post-hearing data requests. On April 12, 2018 Commission Staff issued supplemental post-hearing data requests to Atmos, to which Atmos filed responses on April 17, 2018. Also on April 17, 2018, Commission staff notified the parties via e-mail that Atmos' responses to the Staff's supplemental post-hearing data requests do not sufficiently answer the posed questions, and that therefore, Staff will be posing additional post-hearing data requests to Atmos.

The Commission's March 26, 2018 Order stating that the "case shall stand submitted for a decision" at midnight of April 18, 2018 is no longer of effect as the Commission, through its staff, has indicated it will propound additional discovery on or after April 18, 2018. As such, the Attorney General moves the Commission for leave to late file his post-hearing brief

until such time as the Commission finds that discovery is complete in this matter, so that he is able to adequately provide his position on the completed record.

WHEREFORE, the Attorney General respectfully requests that the Commission grant his motion.
