Before the additional Motions/Objections were filed, the Commission Legal Staff provided the option to the Attorney General to file his post-hearing brief tomorrow, and either (1) address the pipeline replacement program in the brief, and then have the opportunity to supplement the brief based on Atmos' responses, or (2) address the entire pipeline replacement program issue in a supplemental brief. Atmos would also be allowed to file a supplemental simultaneous brief. The Attorney General's Office intends to provide the Commission and Atmos with a response to this procedure issue by tomorrow. If the Attorney General's Office does not agree to this procedure, then the Commission will rule on the merits of the pending Motions/Objections and issue a ruling as soon as possible.
