MOTION TO CORRECT FINAL ORDER

Kentucky Utilities Company (“KU”) and Louisville Gas and Electric Company (“LG&E”) (collectively, “Companies”), by counsel, hereby move the Kentucky Public Service Commission (“Commission”) to make certain technical corrections nunc pro tunc to its Order dated October 5, 2018 (“Final Order”).

In Appendices A and B to the Final Order, the Commission identifies several line items as the DSM Balance Adjustment (DBA) for each rate schedule. However, these values were taken from the Companies' tariff sheets as originally filed on December 6, 2017 as Exhibits REL-1, REL-2 and REL-3 to the Testimony of Rick E. Lovekamp. The DSM Balancing Adjustment for each rate schedule is updated annually and was most recently updated on February 28, 2018 and became effective on April 1, 2018. The table below identifies the DBA amount listed in Appendices A and B of the Final Order and the corrected DBA amount which became effective on April 1, 2018:

In addition, the Companies have removed the references to Rate Schedules School Power Service (SPS) and School Time-of-Day Service (STOD), due to the fact that, effective with the filing of the Companies' most recent rate case filings, they are no longer tariff offerings by the Companies.

WHEREFORE, Kentucky Utilities Company and Louisville Gas and Electric Company respectfully request the Commission to issue an order making the above corrections to Appendices A and B to its Final Order in this proceeding.


