## ALLEGED FAILURE TO COMPLY WITH KRS 278.300

## MOTION FOR DECISION ON EXISTING RECORD WITHOUT HEARING OR, IN THE ALTERNATIVE, FOR DISCLOSURE OF EVIDENCE IN SUPPORT OF ALLEGATIONS OF MISCONDUCT AND THE THEORY FOR LIABILITY

Charles Boren, by counsel, moves the Public Service Commission for a decision on his "Motion for Dismissal As a Party to This Proceeding" on the existing record and without hearing, or in the alternative, for immediate disclosure of the evidence upon which the Public Service Commission relies to form its belief that Mr. Boren aided and abetted Dexter-Almo Heights Water District's alleged violation and the legal theory upon which a member of a water district's board of commissioners can be deemed liable for the unauthorized issuances of evidence indebtedness that may have occurred prior to his or her appointment to such board.

In support of his motion, Commissioner Boren states:

1. On January 11, 2018, the Public Service Commission issued an order in this proceeding in which it alleged that Dexter-Almo Heights Water District willfully violated KRS 278.300 by issuing on or about **December 9, 2009** a promissory note in the amount of \$145,988 payable over a 15-year period to Murray Bank of Calloway County, Kentucky ("Promissory Note").

2. In the same Order, the Public Service Commission found the existence of a *prima facie* case that the present members of Dexter-Almo Heights Water District's Board of Commissioners,

including Mr. Boren, had aided and abetted the alleged violation based upon the members' statutory duty as set forth in KRS 74.020(1) "to control and manage the affairs of the district."<sup>1</sup> The Public Service Commission, however, made no finding as to whether any of the present members of Dexter-Almo Heights Water District's Board of Commissioners were serving as members of that Board at the time of the alleged violation.

3. The Public Service Commission based its Order of January 11, 2018 upon a report that

Commission Staff prepared and filed in the record of Case No. 2017-0191.<sup>2</sup> In that report, Commission

Staff stated:

Dexter-Almo provided a copy of the Promissory Note between itself and the Murray Bank of Calloway County, Kentucky, ("Murray Bank") in the principal amount of \$145,988. This Promissory Note has an origination date of December 9, 2009 and a 15-year term. In Case No. 2006-00420 the Commission granted Dexter-Almo a Certificate of Public Convenience and Necessity to construct the "Coles Campground Road Project" and approved the proposed plan of financing, which included a \$47,613 line of credit with the Murray Bank. In its November 23, 2005 letter, the Murray Bank states that Dexter- Almo's total line of credit was for \$150,000 and that the line of credit was renewable on a two-year term.

According to KRS 278.300, no utility shall issue any form of indebtedness unless it has been authorized to do so by an Order of the Commission. Dexter-Almo currently has an outstanding loan that is payable to the Murray Bank for which Dexter-Almo did not obtain Commission approval as required by KRS 278.300. Dexter-Almo has the responsibility to ensure that it follows the Commission's statutes and regulations and that all statutory and regulatory approvals are obtained. Dexter-Almo should be aware that the Commission may initiate a separate proceeding to more thoroughly investigate the possible violations of Commission statutes and regulations. If a determination is made by the Commission that there has been a willful violation of any provision of KRS Chapter 278 and 807 KAR Chapter 5, the members of the Board of Commissioners may be held accountable.<sup>3</sup>

4. In its report, Commission Staff did not identify the persons who were serving as members of Dexter-Almo Heights Water District's Board of Commissioners on December 9, 2009 or state the relationship between the Promissory Note's issuance and the present members of the Dexter-Almo Heights Water District's Board of Commissioners. Commission Staff further did not allege that Dexter-Almo Heights Water District took any action to conceal the alleged issuance.

5. At the time of the alleged issuance of the Promissory Note, Mr. Boren was not a member of Dexter-Almo Heights Water District's Board of Commissioners. The Calloway County Judge/Executive did not appoint Mr. Boren to the Dexter-Almo Heights Water District's Board of Commissioners until November 2010. The Calloway County Fiscal Court did not approve Mr. Boren's appointment until **November 16, 2010** – approximately eleven months after the alleged issuance. A copy of the minutes of the Calloway County Fiscal Court's Meeting of November 16, 2010 in which this approval occurred is attached as Exhibit A to this Motion.

6. The financial and statistical report for the year ending **December 31, 2009** that Dexter-Almo Heights Water District filed with the Public Service shows that Mr. Boren was not a member of the Board of Commissioners **as of March 31, 2010**. The relevant pages of this report are attached as Exhibit B to this Motion. This document is available on the Public Service Commission's website and was available to the Public Service Commission, Commission Staff and the general public when the Commission Staff issued its Report and the Commission issued its Order to Show Cause.

7. The minutes of the **November 2**, **2009** and **December 7**, **2009** meetings of Dexter-Almo Heights Water District's Board of Commissioners, which have been part of the

record of this proceeding since **April 3, 2018,** clearly identify the members of Dexter-Almo Heights Water District's Board of Commissioners at the time of the alleged issuance. They **do not list** Mr. Boren as a member of Dexter-Almo Heights Water District's Board of Commissioners. A copy of these minutes is attached as Exhibit C to this Motion.

8. On **January 25, 2018**, Mr. Boren filed with the Public Service Commission a written statement in which he advised that he was not a member of Dexter-Almo Heights Water District's Board of Commissioners at the time of the alleged issuance of the Promissory Note. A copy of this statement is attached as Exhibit D. The Public Service Commission took no action upon its receipt of Mr. Boren's statement.

9. On **March 16, 2018**, Mr. Boren, through counsel, filed a motion with the Public Service Commission for his dismissal as a party to this proceeding as he was not a member of Dexter-Almo Heights Water District's Board of Commissioners as the time of the alleged issuance of the Promissory Note. That motion is incorporated by reference into this Motion.

10. On March 22, 2018, the Public Service Commission entered an order in which it declined to rule upon Mr. Boren's motion for dismissal and continued this proceeding generally. In that Order, the Public Service Commission further directed that the Respondents in this proceeding provide certain information. The Respondents provided this information on April 3, 2018. None of the Public Service Commission's inquiries concerned Mr. Boren's appointment to Dexter-Almo Heights Water District's Board of Commissioners or his relationship to Dexter-Almo Heights Water District prior to his appointment.

11. The record of this proceeding does not indicate any additional investigation by the Public Service Commission on the alleged unauthorized issuance of evidences of indebtedness or Mr. Boren's alleged role in such issuance since the Order of March 22, 2018.

12. On **January 22, 2019** – approximately ten months after continuing this proceeding generally, the Public Service Commission ordered that a hearing be held in this matter on April 24, 2019, and that no decision on Mr. Boren's motion for dismissal would be made until testimony was heard on the motion's merits.

13. Given the absence of any evidence in the record of this proceeding or in Case No. 2017-00191 that Mr. Boren participated in any decision involving the unauthorized issuance of evidences of indebtedness, no grounds existed to make Mr. Boren a subject of the Public Service Commission's formal investigation. Considering the overwhelming evidence that Mr. Boren was not a member of Dexter-Almo Heights' Board of Commissioners until eleven months after the alleged violation purportedly occurred, no need exists to conduct a hearing or otherwise defer a decision on Mr. Boren's Motion for Dismissal As A Party. Under similar circumstances in Case No. 2017-00467,<sup>4</sup> the Public Service Commission without conducting a hearing granted a motion to dismiss two commissioners of Jonathan Creek Water District from a proceeding involving an alleged unauthorized issuance of evidences of indebtedness on the grounds that neither commissioner was a member of the water district's board of commissioners at the time of the alleged issuance. Less time elapsed between the alleged unauthorized issuance and the appointment of the two water district commissioners in that proceeding than in the present case.<sup>5</sup>

14. The Public Service Commission's continued inaction causes significant prejudice to Mr. Boren. By its Order of January 11, 2018, the Commission has accused Mr. Boren of committing a criminal offense and impugned his good name and reputation within his

community. By failing to act promptly on his motion for dismissal, the Public Service Commission continues to inflict damage on his reputation. Moreover, by requiring Mr. Boren to appear at a hearing on his motion, it requires him to incur significant expense to travel to Frankfort to respond to an allegation for which the Public Service Commission has yet to identify one shred of supporting evidence.

15. Should the Public Service Commission deny this Motion for Decision, it should disclose the evidence upon which it derives its belief that Mr. Boren aided and abetted Dexter-Almo Heights Water District's alleged violation and the legal theory for holding a member of a water district's board of commissioners responsible for alleged acts of misconduct occurring prior to his or her appointment to such board. Without such disclosures, Mr. Boren will be denied his right to due process under the law as he will not have been provided notice of the factual or legal grounds upon which the Public Service Commission seeks to assess a civil penalty against him.

WHEREFORE, Charles Boren requests that the Public Service Commission issue a decision on his Motion for Dismissal on the existing record and without hearing; promptly grant Mr. Boren's Motion for Dismissal, dismiss him as a party to this proceeding and release him from any obligation to appear at any hearing in this matter; or, in the alternative, immediately disclose the evidence upon which the Public Service Commission relies to form its belief that Mr. Boren aided and abetted the alleged violation and the legal theory upon which a member of a water district's board of commissioners may be held responsible for a water district's alleged misconduct occurring prior to his or her appointment.

## Calloway County Fiscal Court November 16<sup>th</sup>, 2010 – Regular Meeting Minutes

An adjourned regular meeting of the Calloway County Fiscal Court was held at 5:00pm on Tuesday, November 16<sup>th</sup>, 2010, in the Calloway County Judicial Building. Judge Larry Elkins called the meeting to order. The following duly qualify members of the Court were present: Squire Eddie Clyde Hale, Squire Connie Morgan, Squire Bobby Stubblefield, and Squire Johnny Gingles. Also present were: Assistant Judge Michelle Corum, County Attorney David Harrington, County Treasurer Anita Gallimore, Deputy Clerk Antonia Faulkner, and County Clerk Ray Coursey, Jr.

The Court reviewed the minutes from the October 19<sup>th</sup> Regular Meeting. Motion made by Squire Morgan, seconded by Squire Stubblefield, to waive the formal reading and approve the minutes as presented. All voted aye and it was so ordered. Antonia Faulkner read the minutes of the November 5<sup>th</sup> Special Meeting. Motion made by Squire Gingles, seconded by Squire Hale, to approve the minutes as read. All voted aye and it was so ordered.

Anita Gallimore presented the treasurer's report. Motion made by Squire Morgan, seconded by Squire Hale, to approve the finance statement. All voted aye and it was so ordered. Motion made by Squire Stubblefield, seconded by Squire Gingles, to pay the bills. All voted aye and it was so ordered. Motion made by Squire Hale, seconded by Squire Morgan, to approve the transfers. All voted aye and it was so ordered.

Ms. Gallimore then presented the first reading of an Ordinance regarding Budget Amendment #1 to the 2010-2011 Budget. Following a discussion, motion made by Squire Gingles, seconded by Squire Stubblefield, to approve the first reading. All voted aye and it was so ordered. (10-1116-A)

Judge Elkins then recessed the meeting and called to order a public hearing concerning Ordinance #10-1105-A (bonds for the R.T. Vanderbilt expansion). No comments were made and Judge Elkins closed the public hearing and called the Regular Meeting back to order.

The Court then considered the second reading of Ordinance #10-1105-A concerning the R.T. Vanderbilt bonds. Attorney Mike Harrington explained that the County would bear no responsibility for the bonds' repayment. Following a discussion, motion made by Squire Hale, seconded by Squire Morgan, to approve the Ordinance. All voted aye on a roll call vote and the Ordinance was approved.

Judge Elkins stated that action on the closing of Lynch Lane would be considered at a later time because the viewers had not had time to present their findings.

The Court then considered a Resolution allowing for the extension of a lease for two John Deere road graders. Following a discussion, motion made by Squire Gingles, seconded by Squire Hale, to approve the Resolution. All voted aye and it was so ordered. (#10-1116-A)

Judge Elkins stated that the matter concerning West Kentucky Rural Telephone's right-of-way usage would be brought up at a later time.

The Court then considered Board Appointments. Motion made by Judge Elkins, seconded by Squire Morgan, to appoint Charles Boren to the Almo-Dexter Water District Board. All voted aye and it was so ordered. Motion made by Judge Elkins, seconded by Squire Stubblefield, to appoint Ken Cromwell to the Transit Authority Board. All voted aye and it was so ordered. Motion made by Judge Elkins, seconded by Squire Gingles, to appoint Greg Anderson to the Transit Authority Board. All voted aye and it was so ordered.

Jay Wyatt told the board he would need a 10" coupling to be able to repair the waterline incase of a break. The board approved the purchase. Jay also needs a small vise to be able to cinch small water lines incase of a break or meter changeouts. The board said to get quotes from 3 different places and go with the best price and purchase the vise. The board voted to allow Jay to purchase needed items for the district within reason. Any major purchase will need the board's approval.

Jay also reported that the truck will need servicing and prep work fro winter. The board said to get done to the truck what needed to be done.

The board discussed the line of credit note at The Murray Bank that is set to mature December 9, 2009. The broad discussed several options as to how long to go on the note. The board chose to go for a longer time frame so the district can build up funds in case of a major break, a hard to find leak or a major purchase should arise. The board also discussed that when possible we would make extra payments and pay the loan off quicker. Gene Outland made a motion that the district set the note up for 15years making semi-annual payments. Pat Paschall seconded, the motion passed.

## MOTION TO DISMISS KARA WILSON AND JOSH MEDLEY AS PARTIES TO THIS PROCEEDING

Respondents Kara Wilson and Josh Medley (collectively "Respondents") by and through counsel, individually and jointly move for an Order dismissing each as a party to this proceeding on the grounds that they were not commissioners of the Jonathan Creek Water District ("District") on the date of the alleged violation of KRS 278.300 set forth in the Commission's Order dated January 11, 2018 ("Commission's Order").

The Commission joined the Respondents in this proceeding because it found that a *prima facia* case existed against Respondents "acting in their respective individual capacities as members of Jonathan Creek's Board of Commissioners, willfully aided and abetted in the above violation."<sup>1</sup> However, the Respondents were not members of the District's Board of Commissioner's on the date of the violation. Therefore, they could not have willfully aided and abetted in the District.

Under KRS 278.300, no utility shall issue evidences of indebtedness until it has been authorized to do so by order of the commission. The Commission's Order alleges that the District violated KRS 278.300 by issuing a promissory note to Community Financial Services Bank on May 3, 2016, without the Commission's authorization.

As set forth in their respective Responses to the Commission's Order herein, which are incorporated by reference, Respondents were not members of the District's Board of Commissioners on the date of the alleged violation. Kara Wilson did not join the District's Board of Commissioners until February 7, 2017.<sup>2</sup> Josh Medley did not join the District's Board of Commissioners until July 1, 2016.<sup>3</sup> Accordingly, the Respondents could not have willfully aided and abetted in the violation of KRS 278.300 as alleged in the Commission's Order.

WHEREFORE, the Respondents Kara Wilson, respectfully request that they be dismissed as parties to this proceeding.

1. Jonathan Creek's and the Commissioners' request to dismiss the proceeding with prejudice and to cancel the February 27, 2018 hearing is denied.

2. Jonathan Creek's and the Commissioners' joint motion for a telephonic conference is denied.

3. Commissioners Josh Medley's and Kara Wilson's joint motion to be dismissed from the proceeding is granted, and they are excused from the February 27, 2018, hearing.

4. Jonathan Creek and Commissioners Jimmy Tubbs, Barry Hill, and Mark Holt shall attend the February 27, 2018 hearing.

5. Nothing contained herein shall prevent the Commission from entering further Orders in this matter.
