MOTION FOR CHANGE IN TIME OF SCHEDULED HEARING

Respondents move that the starting time for the scheduled hearing in this matter be changed from 9:00 a.m. to 1:00 p.m. In support of their motion, they state:

1. The Public Service Commission has scheduled a hearing in this matter on May 9, 2019, beginning at 9:00 a.m., Eastern Daylight Time.
2. The approximate travel time from Almo, Kentucky to Frankfort, Kentucky is approximately four hours. The approximate travel distance is 255 miles.
3. The Respondents reside in the Central Time Zone.
4. If the hearing begins at the currently scheduled time of 9:00 a.m., Respondents must travel to Frankfort, Kentucky on the day prior to the hearing and must incur the additional expenses related to an overnight stay in Frankfort. Rescheduling the hearing to 1:00 p.m. will permit the Respondents to travel to and return from the scheduled hearing on the same day and avoid the expense of two travel days.

WHEREFORE, Respondents respectfully request that the starting time of the scheduled hearing be changed from 9:00 a.m. to 1:00 p.m.


