DELTA NATURAL GAS COMPANY, INC.'S MOTION FOR CLARIFICATION

Delta Natural Gas Company, Inc. ("Delta") respectfully requests the Commission clarify its December 21, 2018 Order ("Delta") in this matter. The Order established the surcredits Delta is to provide to certain customer classes to reflect the impact of the Tax Cuts and Job Act. The Order, in both the rate design discussion and Appendix B, set forth surcredits for two time periods: (1) January 2, 2019 – March 31, 2019; and (2) April 1, 2019 forward (until new base rates are established in Delta's next rate case).

Ordering Paragraph 1, however, states that the "rates and charges in Appendix B, attached hereto, are fair, just, and reasonable for Delta to charge for service rendered on and after January 1, 2018." Delta believes that the reference to "2018" is a typographical error that should state "2019," and requests the Commission's clarification of same. Because this Motion does not request clarification regarding the amount of the surcredit, Delta will begin including the surcredits for service rendered on and after January 2, 2019.

WHEREFORE, Delta Natural Gas Company, Inc. respectfully requests the Commission clarify that the reference to "2018" in Ordering Paragraph 1 is a typographical error.
