**MOTION FOR AN EXTENSION OF TIME TO RESPOND
TO THE COMMISSION STAFF’S THIRD SET OF DATA REQUESTS**

Columbia Gas of Kentucky, Inc. (“Columbia”) moves the Public Service Commission (“Commission”) for an extension of time to respond to Commission Staff’s third set of data requests, which were filed on June 15, 2018. Currently, the responses are due on June 21, 2018, leaving Columbia only four business days to respond to the requests. Columbia needs additional time to respond to the data requests in order to consult with its expert to present the facts in a complete and responsive way to the Commission. Columbia requests until Jun 28, 2018 to respond to these requests.
