**RESPONSE OF NUCOR STEEL GALLATIN
TO COMMISSION MAY 8, 2018 ORDER**

Nucor Steel Gallatin (“Nucor”) responds to the Commission’s May 8, 2018 Order as follows:

1. No later than 12 p.m., Eastern Daylight Time, on May 14, 2018, each party shall provide the names and titles of each witness the party intends to call at the May 15, 2018 hearing and the order in which the party intends to call its witnesses.

RESPONSE: Nucor does not intend to call any witnesses.

2.
